# **Key Republicans Back Short-Term Graduation Requirement Fix**

The leaders of the House and Senate's education committees are pushing forward with plans to prevent tougher high school graduation requirements from going into effect for the

class of 2019. **Rep. Andy Brenner** (R-Powell), chairman of the House Education & Career Readiness Committee, confirmed in an interview this week he and **Sen. Peggy Lehner** (R-Kettering), chairwoman of the Senate Education Committee, have been working toward a potential fix in the form of an amendment. Sen. Lehner last week said such an amendment likely will be attached to a measure already passed by the House – potentially legislation (**HB 477**) aimed at eliminating outdated education-related laws

Amended measures establishing a committee to analyze student interactions with tenured university faculty and requiring the adoption of a state curriculum on cursive handwriting cleared the Senate Education Committee Wednesday.

The tenure measure (**HB 66**) would create the Undergraduate Mission Study Committee, which is required to evaluate how successful universities are at encouraging face-to-face interaction between experienced professors and students. The bill was approved by a partyline vote after the committee after the committee accepted three amendments, including additions supported by the Inter-University Council of Ohio and the Ohio Association for Colleges of Teacher Education.

Brian Yusko, chairman of the advocacy committee for OACTE, voiced his group's support for an **amendment** to the legislation creating a teacher preparation subcommittee of the Education Standards Board. An amendment to that effect was accepted by the panel without objection.

"This subcommittee would assist and advise the ESB in developing standards for teacher preparation as well as other issues related to K-12 teaching standards about which the ESB may seek input from the teacher preparation community," he said.

Mr. Yusko said the subcommittee would be comprised of: three higher education representatives who already sit on the ESB; two representatives nominated by the State University Education Deans and the Ohio Association of Private Colleges for Teacher Education; and two other ESB members selected by the ESB chairperson. The state superintendent of public instruction and the chancellor of higher education would serve as non-voting members.
