Superintendent Details District Takeover Changes In Budget Bill: "One-size-fits all" takeovers of local school districts would end under Gov. Mike DeWine's budget proposal, the state's superintendent of public instruction told a House panel Thursday. Superintendent Paolo DeMaria went before the House Finance Subcommittee on Primary & Secondary Education to discuss the budget (HB 166), which led to multiple questions about its implications for the state's system for intervening at poorly performing school districts. (Testimony; Redbook). Mr. DeMaria said the budget reflects multiple recommendations from a report the legislature required him to complete on potential changes to the system. Under

the current system, districts qualify for takeovers after receiving three consecutive overall F grades on Department of Education-issued report cards. After a district qualifies, ODE establishes an academic distress commission to appoint a CEO with wide-ranging powers to oversee the district. The superintendent said under HB166, districts would qualify for "substantial and intensive support" after receiving one overall F grade. "This designation – which occurs much sooner than under current law - triggers an academic performance review and resource utilization analysis to identify the specific supports needed," he said. Mr. DeMaria said such schools would receive a "customized system of supports" from ODE after receiving the designation. He said districts would not shed the designation until receiving an overall C grade or unless he determines they are displaying improved academic performance "and capacity for sustained improvement." He said districts already under a takeover could remain under their existing ADC or come to an agreement with ODE on an "alternate intervention." Along with the budget provisions, lawmakers already are debating multiple measures aimed at repealing or replacing the takeover system, which was established in prior legislation (HB70, 131st General Assembly). (See Gongwer Ohio Report, April 2, 2019) Rep. Steve Hambley (R-Brunswick) said the budget seems to propose "really significant changes" and asked if the superintendent agreed. Mr. DeMaria said the biggest change he sees is a move away from a "one-size-fits-all" solution. He said the new system would allow for a closer look into each district's unique challenges. "At the front end there should be deeper analysis of what exactly is going on," he said. Rep. Erica Crawley (D-Columbus) said she views the current state takeover system as one that "for the most part has failed." She asked the superintendent why it has not achieved better results. Mr. DeMaria said he blames "fundamental structural issues" in HB70, including a lack of flexibility. Rep. Hambley said he worries House lawmakers might not have enough time to fully vet the takeover proposal and discuss it with interested parties. He noted budget amendments are due April 12. He also asked the superintendent how the decision was made on which of the report's recommendations would be included in the budget. Mr. DeMaria said he was not "the best person to explain," as he did not finalize the budget proposal. He added that ODE staff are willing to take part in future discussions to help address the lawmaker's outreach concerns. "There are opportunities for more indepth discussions," he said. "We'd be happy to participate in that." Co-Chairman Rep. John Patterson (D-Jefferson) asked if the legislature should be considering changes to report cards, takeovers and testing at the same time. "All of these pieces flow together to form a very complex whole," he said. The superintendent said although the topics are linked, he would argue there is a "good bit of discreteness" that would allow lawmakers to address them separately. Sen. Peggy Lehner, R-Kettering, chairwoman of the Senate Education Committee, said she's been working with a group of superintendents and principals on crafting a replacement. She would like to see it included in the budget bill, which is supposed to pass by the end of June.

3. HB 88: An Ohio State University professor told a House panel Tuesday that legislation designed to promote free speech on campuses could have to opposite impact. Lisa Voigt, testifying on behalf of the Ohio Conference of the American Association of University Professors, told members of the House Civil Justice Committee that the legislation (HB 88)

is unnecessary because First Amendment rights are not in jeopardy on college campuses. "College and university faculty care deeply about free speech. It is the foundation of academic freedom, one of the key principles of the AAUP," she said. "Free speech is not simply an aspect of the educational enterprise to be weighed against other desirable ends. It is the very precondition of the academic enterprise itself." Ms. Voigt, however, drew a distinction between banning an idea and disallowing a controversial speaker who will cause massive disruptions on campus. "If legislation like this would be approved, thus taking these decisions out of the hands of the institutions, we would expect that the legislature would also provide funding to cover the costs of the crowds and necessary security that hosting controversial speakers would entail," she said.

I just wanted to give a heads up so that you are aware that your President/Provost may have been sent an NCTQ email that involves your programs/college.
