While the budget is the primary focus for the Legislature, the next couple of weeks should continue to be interesting. It is a new year and the slate has been wiped clean (sort of).

Proposed Legislation:

1.

HB 305

SCHOOL FUNDING (CUPP, R., PATTERSON, J.) To create a new school financing system, and to make an appropriation.**Referred** in House (6/28/2019) **Introduced** in House (6/26/2019)

2.

SB 181

WORKFORCE PROGRAM (Coley, B.)

To require the Chancellor of Higher Education to create a template for workforce-education partnership programs.

3.

HB 121

TAX CREDIT (Schaffer, T.)

To allow a credit against the personal income tax for amounts spent by teachers for instructional materials.

4.

HB 321

SEXUAL ABUSE EDUCATION (Lipps, S., Kelly, B.)

With respect to age-appropriate student instruction in child sexual abuse and sexual violence prevention and inservice staff training in child sexual abuse prevention.

Under the bill (<u>HB 321</u>), traditional school districts, charters and STEM schools would be required to provide instruction on sexual abuse prevention to students in grades K-6 and sexual violence prevention to students in grades 7-12

On behalf of the Ohio Deans Compact on Exceptional Children, I am pleased to inform you about the upcoming release of a request for application (RFA) for a new round of incentive grant funding designed to improve IHE capacity to prepare educators to improve early language and literacy outcomes for all children.

This is a separate RFA from the incentive grant competition that closed in July 2019. Proposals will be sought in one priority areas: to work in partnership with school districts to improve literacy instruction. Efforts must align with *Ohio's Plan to Raise Literacy Achievement*.

The RFA will be released on Friday, August 23, 2019; proposals must be submitted no later than 4:30 pm ET on Friday, October 4, 2019.

Survey Shows Widespread Discontent Among Educators

A recent national poll that found half of all public school teachers have considered leaving the profession rang true to education groups in the Buckeye State.

The Phi Delta Kappa survey of a random sample of 2,389 adults, which included 556 public school teachers and 1,000 parents of school-age children through oversampling, also found 60% of teachers view their pay as unfair. The percentage of teachers who felt they received appropriate compensation was highest in the Northeast region of the country (60%) and lowest in the Midwest (30%) and South (28%). The results were not surprising to education groups in Ohio.

DeWine Creates School Safety Center

Gov. Mike DeWine on Wednesday unveiled plans to improve school safety as part of an ongoing effort to curb gun violence. Through an executive order, the governor created the Ohio School Safety Center, which will launch Thursday with seven staff members. "This will be a comprehensive statewide school safety office," Gov. DeWine said at a Statehouse news conference. The center, a specialized division of Ohio Homeland Security, will be housed in the Department of Public Safety, which will shuffle personnel to provide staffing. Among its charges, the center will be tasked with using enhanced technology to monitor the Internet for threats to schools. It will also review school emergency management plans, offer free risk and vulnerability assessments, promote and expand the use of the SaferOH tip line (844-SAFEROH) and host an annual school safety summit. The center will also consolidate resources on school

safety at <u>saferschools.ohio.gov</u> The executive order also created the Ohio School Safety Working Group, which will meet quarterly and produce an annual report on the state of school safety in Ohio. Gov. DeWine called the moves a beginning and said he hopes to build on them through legislation. "I believe the Ohio School Safety Center will be a key tool in preventing violence in our schools," he said. DPS Director Tom Stickrath called the center "a vehicle for local communities to strengthen their current capacities." Some of the order is modeled after legislation (<u>HB 123</u>) sponsored by <u>Rep. Gayle Manning</u> (R-N. Ridgeville), who attended the press conference with <u>Sen. Frank Hoagland</u> (R-Adena).
