- 2. Introductions
- 3. Accomplishments
 - a. Position Statements-We have developed position statements on bills that are threatening to teacher preparation in order to be ready and proactive. The Advocacy Committee has been being proactive with the support of Ann Shelly on issues like CRT, which is something that keeps resurfacing. Brian Yusko recommended that OACTE should continue to be ready with position statements to try to stay ahead of the legislature. The Advocacy Committee has been reviewing and revising the legislative platform of the group so that it is easier to respond in a timely manner. Heather thanked Brian for his leadership on this.
 - b. Gap Grants-The goal is to share information among those going through their accreditation visits. We fund projects that get shared in the spring. We funded 5 grants this summer. Baldwin Wallace, Mt. St. Joseph, Notre Dame College, University of Akron, and the University of Findlay. The project is funded half up front and then they receive the other half after the presentation in the spring conferences.
 - c. OCTEO Conference-the conference is a major accomplishment reflects the level of collaboration between private and publics
 - d. Program Review Process Recommendations-recommendation was made to the elimination of some of the requirements for the mandated content, including Ohio Standards for Professional Development and the Operating Standards. The other change that is being reviewed by legal evidence of faculty credentials that included minimal standards related to the revised code (something few people understood how that could be measured).
- 4. Secretary Report—Tanya Judd
 - a. Approval of Spring 22 Minutes
 - a. Motion for approval is made Mary Heather Munger. Seconded by Diana Garlough. Passed unanimously.
- 5. Treasurer Report—Mark Seals
 - a. Dues Status-spreadsheet sent with the board materials by Mary Heather Munger via email prior to the meeting. Check to see your institution's status. Invoice was sent approximately 3 weeks ago.
 - b. Fee Structure-no changes recommended at this time.
 - c. Member Institutions-51 currently. We have lost a few institutions.
 - d. Addendum 1 shows the current financial report for OACTE.

- e. OCTEO-we have spent very little recently. We are over \$36,000 at this time. Mark Seals expressed gratitude to the Deans Compact who has partnered with us in the last few years on the spring meeting. Addendum 2
 - a. Recommendation-the Gap Grants used to be funded by OCTEO when OCTEO was struggling as a result of the conference in the past. We could look at potentially at taking those funds back out of OCTEO instead.
- f. Motion to approve the financial reports made by Jane Bogan. Motion was seconded by Alicia Crowe. Passed unanimously.
- g. Motion made by Mary Heather Munger to pay Ann Lundquist \$3000 out of the OCTEO budget for her assistance and support of the OCTEO Conference for work she is doing outside of the time with her regular work hours at Bowling Green. Seconded by Mark Seals. Passes unanimously.
 - a. Income from the OCTEO conference could be used to provide a regular stipend for conference organization.
- h. Discussion regarding funding for the gap grants and the money transferred between OACTE and OCTEO.
 - i. Brian Yusko shared that he felt that the gap grants should be paid out of OACTE rather than the conference fund at OCTEO.
 - ii. Should we transfer the funds that OACTE had transferred to the OCTEO fund over the years? Should we be paying the fund back?
 - iii. Recommendation-pay the OCTEO bills for this conference and then review the remaining funds. The treasurer should review the previous transfers from OACTE to OCTEO so that it could be repaid at least in part. Once it is determined the amount of funds that remain after OCTEO 2022 with start up monies for the next conference a virtual vote could happen to approve the transfer.
 - 1. Spring 2015 minutes reflect that we transferred \$6000 to OCTEO. Robin Dever is continuing to research this.
- i. Conference cost-we were able to charge less for registration we can use this funding to encourage more students (undergraduate and graduate) as well as P-12 educators.
- j. New institution in the area is God's Bible College. We need to follow up with them to invite them and follow up on dues.

6. Legislative Update-Ann Shelley

- a. Mary Heather Munger and Brian Yusko met with her in September and Ann expressed interest in continuing as the liaison.
- b. Most legislation is on hold until after the election as it is a lame duck session. There are some legislators nearing the end of their terms who are trying to make their mark which can be challenging.
- c. Ann has recommended keeping an eye out on 616 (CRT) which has continued to come up and is alive and well. It was written to parallel the similar legislation in Florida. ALEC is a group that will assist you in writing this type of legislation. Focuses on anything that is considered divisive and racist (in terms of anti-white). It is in the State and Local Committee rather than in the education committees.
 - i. 322 (teaching current events that deal with race, sex, gender, identity has to be vetted); 327 (divisive projects). Both would handicap the curriculum in P-12 schools. What many don't understand is that the interpretation is so open that anything can be challenged. These are both in State and Local
 - ii. HB 529-would require that public schools have to publish all curriculum (lesson plans, readings, materials) by July.
- d. HB 99-arming school personnel, which boils down to anyone in schools to open carry. It is in the Veterans and Public Service and the Criminal Justice Committees.
- e. There is new proposed legislation (SB 361) regarding veterans being able to be teachers without a degree but has 60 hours required (introduced on October 3rd). If anyone is interested in developing a policy statement, Dawn Sinew is helping craft that over email. Contact Dawn Shinew or Alicia Crowe if you are interested in helping craft that statement.

- f. Another bill would eliminate the teacher residency program (number unknown). It includes language about cis-girls and trans-gender girls into this legislation and athletics. This could lead to the loss of the teacher residency program because it contains this language around gender.
- g. Also watch the anti-trans resolution school board meeting. It was tabled for now. It begins with positive language about protecting students and families. Then it goes on to say something to the effect of providing support for districts who want to seek exemption from federal law protecting that community. It also would have the state superintendent writing to district superintendents to not follow Title IX.
 - i. There is now a substitute resolution that has been sent to the executive committee. There will be an opening meeting on October 31st at 12:30pm on this topic. They are not accepting public comments however. It removes some of the most offensive language but not all of it. It still has a focus on trans-gender girls specifically.
- h. Election day is approaching so the next 20 days will be quiet.

7. Honesty in Education Discussion and Vote

- a. This was an outgrowth of the censorship bills that were facing Ohio. This was a group that was hosting sessions allowing people to speak out, which included many organizations that OACTE partner with.
- b. The Advocacy Committee discussed whether OACTE should be added to their list of organizations that are supporting the work of this organization. In June 2022 we had a letter reaching out to this organization to partner.
 - i. There was broad support among the OACTE membership, but there was a concern raised as to whether or not the clear political alignment of this group would make it challenging to work with legislators with different views.
 - ii. The other concern was the level of commitment in terms of finances or time was something we could sustain.

c. Discussion

- i. The primary concern discussed is the impact of how partnering with the organization might close some doors with legislators.
- ii. A suggestion was made that regardless of our decision regarding partnership, a role we can play is by making sure that our membership is familiar with the work of this organization and its resources.
- iii. Recommendations-
 - 1. Could we ask for something in writing about expectations from their organization, including how we can end the relationship if we felt we needed to do so?
 - 2. Could we ask any of the other partners about their experience?
- iv. An informal vote was taken regarding collecting the above information was taken. The vote passed without dissent.

 - a. AACTE's strategic plan is under review. Detail is provided in the addendum.
 - b. The priority areas
 - i. Advocacy
 - ii. Advancing the Profession
 - iii. Diversity, Equity, and Inclusion
 - iv. Educator Shortage-they are referring to this as their "North Star", where they are prioritizing their work on increasing enrollment and enhancing preparation programs embedded in colleges and universities in a variety of forms (traditional, 2+2, alt cert) that address the teacher shortage and a diversification of the workforce.
 - c. There is an AACTE Futures Task Force that is meeting. There is some participation from Ohio there (Dean from Ohio State perhaps?). They are looking 5-10 years down the road at where the profession is heading to stay ahead of trends so that they can support members.
 - d. AACTE still does focus on the federal level policy, but they recognized that most policy takes shape at the state level and they are trying to
 - i. November 1st-State Leaders Meeting, \$50 fee, virtual. They will be talking about the key priorities as the state level, such as the teacher shortage, educator diversity.
 - e. Academic censorship is on their radar as well both in K-12 and higher education.
 - f. At the federal level they are also pushing for things around Public Service Loan Forgiveness, the TEACH Grant and portability of licensure.
