1. Accomplishments

- Opportunity AACTE/ ASCR grant Brian
 - o AACTE runs a competition for state grants much like we do for our Gap Grants; The idea is that they offer for up to 3 grants each one for up to \$10,000.00. The grants are awarded to a state chapter, but each state chapter can work in conjunction with other agencies (such as OAPCTE, SUED, P-16 partners, etc.) The themes are Advocacy and Policy Leadership, Enhancing Program Quality, or Partnership and Communication. Brian shared some ideas: development of instrumentation or assessment (CPAST, dispositional assessment) assemble a gathering of different constituent groups to work on a particular issue that is pressing in the state (Nebraska hosted a summit on teacher shortage state dep P-16, superintendent orgs to work together on the problem) Advocacy activities (Day on the Square/ travel/refreshments/ host meetings with legislators) Submission Deadline is June 30. Awards are announced in the summer Funds are released in September. Winners are expected to share their projects at the AACTE conference in February.

7. Legislative Update – Ann Shelly

- The legislature has been very active
- SB 1 changing dept of education and doe & workforce dev & under the governor passed senate – is now in the house
- HB12 to change dept of ed is currently being discussed in the Primary and Secondary education Committee
- SB 83 "Higher Education Enhancement Act" will forbid faculty from striking, and each institution will not be allowed to take a stand on any controversial issues, forbids required DEI work – this would have ramifications for our accreditation
- There is a lot of focus on curricula
- The Governor signed an executive declaration calling for the teaching of the science of reading the budget bill has money in it to retrain teachers in the science of reading
- HB9 We brought talking points to the legislators with whom we met to articulate points of support (loan forgiveness, scholarships, professional development) and points of opposition (changing the grade bands).

8. P-16 Collaborative for communication and advocacy

 Alicia recommends reviving this. It brought together OSBA, BASA, SUED, OAPCTE, OACTE, and Unions to talk about common issues (every other SUED meeting) Reaching out to more groups associated with K-12 might be helpful. Let's continue to think about ways we can do this.

9. Open Seats/ Nominations

Committees need help – particularly with professional advancement – new members will be assigned to
groups to help, also think about how we could use grant funding and our surplus in the OACTE account –
perhaps for travel for bringing students to OCTEO

10. Committee Updates

- a. Advocacy organizing a Day on the Square (April 19), organizing a multi-pronged approach of sending letters and meeting in person, funding to pay for advocacy training was suggested (maybe the AACTE grant), multiple trips and sustaining a robust, routine plan for advocacy, and solidifying the platform, looking at ORC and OAC to make a chart/ map of issues
- b. Professional Advancement gap grant proposals due end of May, discussed putting together a virtual orientation, nominations for election of new members was discussed, OACTE Awards should be revived, people want more celebrations/ awards of good work, outgoing board members also received recognition c. Inquiry Robin needs to know who the outgoing members are and where they should be mailed, research roundtables are being organized, the inquiry committee would like to do a presentation on the
