4. **HB 58 CURSIVE HANDWRITING** (Brenner, A., Slaby, M.) **Now in Senate.** To require the State Board of Education to develop and adopt a model curriculum in cursive handwriting instruction, which may be used by public schools. CONTINUED (1st Hearing-Sponsor) Rep. Marilyn Slaby (R-Akron) said the proposal would charge the State Board of Education with establishing a model curriculum involving cursive handwriting, a skill she said would help students learn sounds and literary skills, as well as boost cognitive development.
 5. **HB 360 BULLYING** (Greenspan, D.) To enact the "Ohio Anti-Bullying and Hazing Act" with regard to school discipline and bullying and hazing policies at public schools and public colleges. CONTINUED-SUBSTITUTE (2nd Hearing-Proponent-Possible amendments). Chair Lehner said the substitute – developed in consultation with Sponsor Rep. Dave Greenspan (R-Westlake) and others – offers different options for discipline rather than including strict expulsion language.
 6. **HB 477 SCHOOL OPERATIONS** (Koehler, K.) To eliminate various provisions and programs related to the Department of Education and the operation of primary and secondary schools. CONTINUED (1st Hearing-Sponsor). Rep. Kyle Koehler (R-Springfield) told the panel the bill eliminates several sections of outdated or unnecessary education-related laws and amends other sections to align the code with those changes.
 7. **HB 713 MENTAL HEALTH** (Lepore-Hagan, M.) . With regard to mental health services in public and nonpublic schools, to require school districts to employ school psychologists and intervention specialists, to provide an additional state payment to school districts for school psychologist and intervention specialist services, and to make an appropriation.
 8. **HB 752 HEALTH STANDARDS** (Sykes, E.) To require the State Board of Education to develop and adopt health education standards for grades kindergarten through twelve and to require only venereal disease education standards and curriculum adopted by the State Board to be approved by concurrent resolution of the General Assembly. Referred House Education & Career Readiness
 9. **HB 491 EDUCATION LICENSE** (Edwards, J.) To require the State Board of Education to issue a substitute license to specified pupil services personnel.
 10. **SB 330 MENTAL HEALTH EDUCATION** (Schiavoni, J.) To require the State Board of Education to adopt standards for mental health education, to require school districts to include mental health education in their curriculum, and to make an appropriation.
 11. **HB 428 STUDENT EXPRESSION** (Ginter, T., LaTourette, S.) Regarding student religious expression and to entitle the act the "Ohio Student Religious Liberties Act of 2018." Committee Hearing in Senate Education (CONTINUED) (Agenda)
 12. **SB 325 BACKGROUND CHECKS** (Kunze, S.) With regard to background check policies and sexual misconduct policies for public and chartered nonpublic schools. CONTINUED (1st Hearing-Sponsor) Sen. Stephanie Kunze (R-Hilliard) said in sponsor testimony the measure revises current state law, which already requires Bureau of Criminal Investigation and FBI background checks for prospective school employees. "Senate Bill 325 provides additional safeguards to further ensure that any school employee that is hired by a school district is someone that has been thoroughly vetted by the hiring district," she said. In addition to the background checks, the law will require school districts to check with the Department of Education's Office of Professional Conduct to determine whether the candidate has been cited for prior misconduct,

Sen. Kunze said. The measure also requires districts to contact prior education-related employers of prospective hires and sets 20 business days as the deadline for a school or district to respond to a prospective employer's request for a personnel file.

13. **HB 502 YOUTH SUICIDE** (Anielski, M.) With regard to educator inservice training on youth suicide awareness and prevention in public schools. CONTINUED (1st Hearing-Sponsor)
14. **HB 630 GRADUATION REQUIREMENTS** (GALONSKI, T.). To extend the alternative graduation requirements for two additional years. --1st Hearing-Sponsor
15. **HB 758 COLLEGE SPEECH** (ANTANI, N., BRENNER, A.). To enact the "Forming Open and Robust University Minds Act" regarding free speech on college campuses. --2nd Hearing-Opponent & interested party
16. **HB 66 TENURED FACULTY** (YOUNG, R.) To establish the Undergraduate Mission Study Committee to evaluate each state university's efforts to secure participation in the undergraduate mission by the university's tenured faculty members. --4th Hearing-All Testimony-Possible amendments & vote
