



This has been a busy and exciting week in the “lame duck” session of the House and Senate. Things have moved quickly and it has been difficult to follow the movement of amendments and legislation. Education has been an active area (although guns, abortion, and other issues have been most heated and active). The next couple of weeks should continue to be interesting.

To grant residency status for in-state tuition purposes at state institutions of higher education to all military service members who are on active duty and to their spouses and dependents. 84-0

To require the State Board of Education to issue a substitute license to specified pupil services personnel, to make changes regarding the circumstances in which school treasurers may be held liable for a loss of public funds, to require school districts to adopt a policy for assignments completed in connection with a suspension, to revise school resource officer training course requirements, to permit the Counselor, Social Worker, and Marriage and Family Therapist Board to temporarily approve certain counselor education programs, and to extend alternative high school graduation pathways through the class of 2020. 78-1 (Duffey)

Plan To Extend Easier Graduation Requirements Sent To Governor

A measure keeping relaxed high school graduation requirements in place for an extra year is heading to Gov. John Kasich after the House on Thursday concurred with changes to a measure that cleared the Senate earlier in the day. The lower chamber's 78-1 concurrence vote followed the upper chamber's unanimous approval for the legislation (HB 491), which initially was focused on licensing for related services providers. The Senate Education Committee on Wednesday



added the short-term graduation requirement fix as an amendment to the bill. (See Gongwer Ohio Report, December 5, 2018)
