Senate Appears Poised To Act On School Takeovers

The Senate Education Committee is set to continue its review of the state's system for intervening at struggling school districts when it returns to action Tuesday.

The panel's lone charge for the upcoming meeting is a second hearing of legislation ([HB 154](#)) that would dissolve all existing academic distress commissions. Only invited testimony will be accepted.

[Sen. Peggy Lehner](#) (R-Kettering) said in an interview she expects the committee will adopt a substitute bill in place of the House-passed legislation quickly after returning to action. ([Most Recent Substitute Bill Draft](#)) "We'd like to get this done before we get too far into the fall," she said. Sen. Obhof said the full chamber could take up the legislation later this month or in early October. He said that he has met with [Rep. Joe Miller](#) (D-Amherst) – the Democratic co-sponsor of HB154 – to discuss his concerns with potential Senate changes to the measure. "We'll see where that ends up," Sen. Obhof said. The final substitute bill should bear much in common with a plan considered by the Senate as a potential budget ([HB 166](#)) amendment but ultimately left out of the spending outline, Sen. Lehner said.

Ed Board Sends Reading Guarantee Recommendations To Legislature

The State Board of Education on Tuesday asked lawmakers to tweak state law to require reading intervention for more students after third grade.

The board unanimously approved a [resolution](#) recommending multiple legislative changes to the state's Third Grade Reading Guarantee.



The state currently requires schools to use improvement and monitoring plans for students identified as reading below grade level through third grade. The BOE recommends that requirement be extended through fifth grade.

"The Board recognizes that providing reading improvement and monitoring plans beyond grade three would be beneficial and provide continued literacy support for students who have been identified as needing it," the resolution states.

The panel also backed legislative changes requiring "intensive reading instruction" through fifth grade for students that have received remediation for two prior school years for not reading at grade level and were held back at least once through third grade.

The resolution also suggests providing intervention through grade five for students exempt from meeting the guarantee's promotion score under existing law.

Another recommendation called for a legislative change allowing local officials to determine whether English learners should be exempt from the guarantee promotion score "based on the student's English language proficiency." Currently, such an exemption is allowed when a student has been enrolled in a school in the U.S. for less than three full years and has had less than three years of English as a second language.

"The Board recognizes that English learners master English language skills at paces that may vary from student to student, and studies show that the average amount of time to master English language skills exceeds three years," the resolution states.

School Report Cards

Lawmakers already established a study committee via the budget ([HB 166](#)) to review how report card grades are calculated and other aspects of the evaluation system before filing its recommendations by Dec. 15.

The Department of Education on Thursday unveiled its [2018-19 Ohio School Report Cards](#), which, taken in total, showed improvement in performance index, the four-year graduation rate and English and math proficiency.

"First and foremost, it's a really good report card," Paolo DeMaria, the state's superintendent of public instruction, said in an interview. "It has a lot of indicators that show we're making progress."



Thirty-one of the state's public school districts, or 5.1%, earned overall A grades, up from 28 (4.6%) the previous year. Only four districts (0.7%) earned overall F grades, down from 14 (2.3%) last year. ([Results](#))

A plurality of districts – 46.4% – received C grades, up from 41.6% for 2017-18.

Mr. DeMaria said 12 of the 14 districts that received overall F grades for the previous school year earned D grades this time around.
